- 3) The online payment receipts along with evaluated photo copy of answer script should be submitted to Controller of Examinations (or) Additional Controller of Examinations.

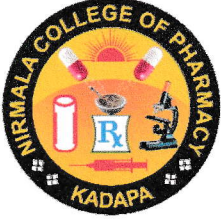

### Guidelines for Challenge Valuation

- 1) A student has to apply for the photocopy of the answer script before applying for the challenge valuation by paying of Rs.2000/- (Rupees Two Thousands only) in office, within 2 weeks from the due date of announcement of the results.
- 2) A student may apply for challenge valuation with revaluation of photo copy of answer script by his/her teacher through authenticated channel and even after evaluation by his/her teacher if not satisfied, may apply within 30 days from the date of announcement of results. The challenge valuation results will be announced within 60 days from the date of announcement of results.
- 3) The application form for challenge valuation shall be made available for download from Drkvsrip.ac.in under exam section. The application form signed by student, parent/guardian of the student and Principal must be submitted along with photocopy of answer script duly revaluated by his/her teacher as an enclosure.
- 4) A student applying for challenge valuation shall pay fee of Rs 5,000/- (Rupees Five Thousands only) in office.
- 5) In case, if the student has got passed after the challenge valuation, the student shall be refunded 50% of the amount.
